# Review of Provincial Regulations to Support the $Education\ Act$

Superintendent, D. Keohane indicated that a response to new provincial regulations is due by January 31, 2015. There are 16 new provincial regulations that have been developed.

**Trustee McEvoy: THAT** the Board of Trustees direct the superintendent to seek clarification from the Department of Education with respect to the rationale for specific private schools being exempted from the requirements of all other schools funded by public tax dollars within the province. And furthermore, should it be determined that the exempted schools are funded through public dollars, that a submission to Alberta Education by January 31<sup>st</sup> be made that assures the inclusion of the same accountability related requirements for all private schools that are publicly funded within the province.

**THAT** the Board of Trustees direct the superintendent to make a submission to Alberta Education by January 31<sup>st</sup> that supports the ACSTA's submission regarding recommended changes to the Establishment of Separate School Districts Regulation, Board Procedures Regulation, and Student Transportation Regulation.
