PRESENTATION

Adryan Slaght, Director of Planning and Development, for the City of St. Albert provided Trustees with an overview of the upcoming Area Structure Plans, including projected populations and expected timelines for development. Trustees had an opportunity for questions.

POLICY REVIEW FRAMEWORK

Trustees reviewed Policy 10: Policy Making; and Policy 15: School Closure/Realignment. Both policies will move to the Regular meeting on February 25, 2019 for approval with no substantial revisions from what was presented.

SAFE & CARING SCHOOLS REPORT

Superintendent Keohane presented the report highlighting several factors that contribute to strong community satisfaction with the District, such as: Suspension Rates, Student Accidents, Critical Incident and Emergency Response Readiness, Bullying Deterrence, Safe Journeys to School compliance, Student Wellness, Occupational Health and Safety, and the Gallup Student Poll on Hope, Engagement, Entrepreneurial Aspirations, and Career/Financial Literacy. Trustees asked questions and received clarification

INSTRUCTIONAL CALENDAR

Assistant Superintendent Moroziuk reviewed the proposed calendars for 2019-20 and 2020-21 with Trustees, after input from all parent councils and staff, indicating the early dismissal at SACHS and VJM has been eliminated and replaced with a Fall Break for a trial period of two years.
