Chair Update: RCASB executive have sent out letters to various members of the newly elected government.

RCASB has been invited to be a member of the Alberta Rural Education Symposium committee. This is a good fit to be sitting in this committee and RCASB is looking for a trustee to be the RCASB representative.

Chinook Edge proposal: proposed that the RCASB ask zone ¾ to change their by-laws to include RCASB as Zone 10. Proposal was voted against and therefore withdrew at the SGM-AGM.

Budget update: 42 boards comprise RCASB

(what constitutes to be considered a member of RCASB? if your board deals with rural concerns of any type)

Total annual estimated cost of RCASB is \$39, 144.00 estimates cost of each board is \$932.00

Advocacy: Bevon Daverne messages well done-stay with you for a long time, whether you like/dislike agree/disagree with the product. if the messaging is done correctly when you hear it you recognize it. everyone has to have the same message to go forward and to sustain ground.

Eg. in 2017 when the CEU issue became known some boards stated it affected them, some sent a message to gov't that it wouldn't affect them and some said they would wait to see the outcome. no clear message from the some 61 boards across the province until 2019 when all boards were stating the same message is when the CEU were re-instated.

The goal is to get all education partners stating the same message, ASBA, ASCTA, ATA, CASS, PSBAA, ASBOA, ASCA etc. to be able to better impact education

Each board was asked to prioritize a list of post election advocacy items for the RCASB to make an advocacy plan from.
