Ward Structure Review

Secretary-treasurer D. Schlag shared a package of information gathered to provide existing information around current ward structure and options for new configurations that would accommodate either 7 or 5 board members. The information also presented the need to address representation of the newly added districts of Cardiff and Cunningham, resulting from the St. Albert and Sturgeon Valley School District Establishment Act effective July 1, 2012. Discussion among trustees centered around the need for a structure that would ensure representation of the existing population and that smaller areas, like Legal retained a voice at the board table. This also included discussion around the merits of having wards with dedicated trustees vs. wards being represented by more than one trustee. Further information was requested and the discussion will continue in the following weeks with a final recommendation targeted for early February 2013.
