#### **Report from the Chair**

Trustee Radford shared correspondence including many Christmas greetings received and two letters; a letter from Education Minister Dirks acknowledging the growing pressure resulting from increasing student population and accolades from Mayor Nolan Crouse congratulating Greater St. Albert Catholic Schools on their outstanding 2013 - 2014 Annual Education Report. He extended his gratitude to students, staff and the parent community for their part in achieving this success.

#### **Report from the Superintendent**

Superintendent Keohane shared an update from the recent school results reviews highlighting the promising practices identified through the review that will be shared with schools.

Assistant superintendent Quick presented a report on the District's Inclusive Education Programming. In addition, a summary report was provided on the Regional Collaborative Services Delivery that is in place in the region and in its second year of implementation.

Superintendent Keohane provided an overview of the District's performance on providing a safe and caring environment. It was highlighted that perceptions of our schools as being safe environment are rated as "excellent" as measured by the Accountability Pillar Report.
