ACTION ITEMS

- The Board approved the conceptual work completed on the St. Albert K-9 Jensen Lakes School.
- The Board approved to maintain transportation fees for the upcoming school year at current levels.
- The Board has approved the elimination of ECS fees and Learning Resource Fees for all grades for the 2016/2017 school year with the exception of out-of-province fees. It is expected there will be funding from the Government to cover these fees and the decision aligns with the Minister of Education's expectation that districts address school fees.
- The Board acknowledged with regret the resignation of long-term Trustee Dave Caron.
