SUBJECT: Impact of High School Flexibility on Student learning

ISSUE

High School Flexibility was first introduced in SACHS and MCHS 3 years ago and at ESSMY a year later. Alberta Education was hopeful that increased flexibility in high school programing would result in more students completing high school. Our question for consideration is what, if any impact has high school redesign had on student achievement and high school completion?


BACKGROUND

Traditional high school was based on 25 hours of instruction for each CEU awarded to students. It was clear to educators that many students could achieve the outcomes with less time than the required 25 hours while other students needed more instruction to be successful. High school flexibility gave schools permission to adjust their instructional time to provide some students with less time while increasing instructional opportunities for others with the creation of flex time.

CURRENT SITUATION

We have tried different models of flex time in district high schools. SACHS began flex with a daily block of 28 minutes as a part of the instructional day. They experimented with the time of day it that it was offered and found that a flex block mid-morning has the highest attendance and increased levels of engaged students and staff with students using the opportunity to seek additional help from teachers in courses where they were experiencing difficulty. Throughout the implementation of flex at SACHS, we monitored student results and other measures on the Accountability Pillar. The results showed steady growth in the overall Pillar over the 3-year implementation. Gallup Student Poll was used to measure student engagement over the implementation period and the number of engaged students increased while the number of actively disengaged students decreased. ESSMY followed the lead of SACHS adopting the 28-minute flex block.

MCHS choose a model of a flex day that allowed students a full day every month to receive additional support, catch up on work or to participate in activities in the school or community. The Accountability Pillar and the Gallup Student Poll were monitored closely and several questions arose. We looked at other flex models that had been developed in schools across the province and found that most schools had adopted a model that provided for more frequent flex periods. A decision was made to change the model in MCHS to one more similar to other





schools in the province, where students could get additional support from teachers on a daily basis rather than a once a month model. School results will continue to be monitored to determine if the change in the way flex is provided has a positive impact on student learning and high school completion.

KEY POINTS

There are many factors that influence the Accountability Pillar and the level of student engagement as measured by the Gallup Student Poll. We will need to continue to collect data from our high schools to determine the long term impact of the introduction of flex time.

Initial results would seem to indicate that a flex model that provides regular student access to teacher support during flex time has a positive impact on success indicators and engagement.

VJM has now created the junior high version of flex time which has been received very positively by students shown in the surveys that were recently done with parents and students.
