CALL TO ORDER

POLICY REVIEW FRAMEWORK

Trustees reviewed Policy 11: Board Delegation of Authority; Policy 13: Appeals and Hearings Regarding Student Matters and Policy 20: Laura Bird Memorial Beacon of Hope Award. All three (3) policies will move to the Regular meeting on January 28, 2019 for approval with no substantial revisions from what was presented. The changes to policy 11 are to incorporate the Guide to Education expectations regarding online learning and shared responsibility programs. The Laura Bird Memorial Beacon of Hope Award Policy 20 background statement includes a revision to provide clarity that ensures all staff members who meet the criteria are eligible.

Review of Inclusive Education Programming

Assistant Superintendent, R. Nixon presented the report highlighting the extensive work on the review and updating of Safe and Caring policy and procedures has been quite intensive. The District has done excellent work in completing this and it is being recognized by other jurisdictions. Nixon highlighted new initiatives that are providing great results in supporting students. It was also noted that a grant to access the Wellness Fund was submitted and that the anonymous reporting system See It, Report It tool has been used by our students appropriately resulted in investigating and addressing inappropriate behavior.

Alberta School Councils' Association Awards

Superintendent, D. Keohane reviewed the award categories and criteria and noted it would be shared with principals and School Council Chairs at their upcoming Council of School Council Meeting. It was highlighted that nominations need to be submitted by February 28, 2019.
